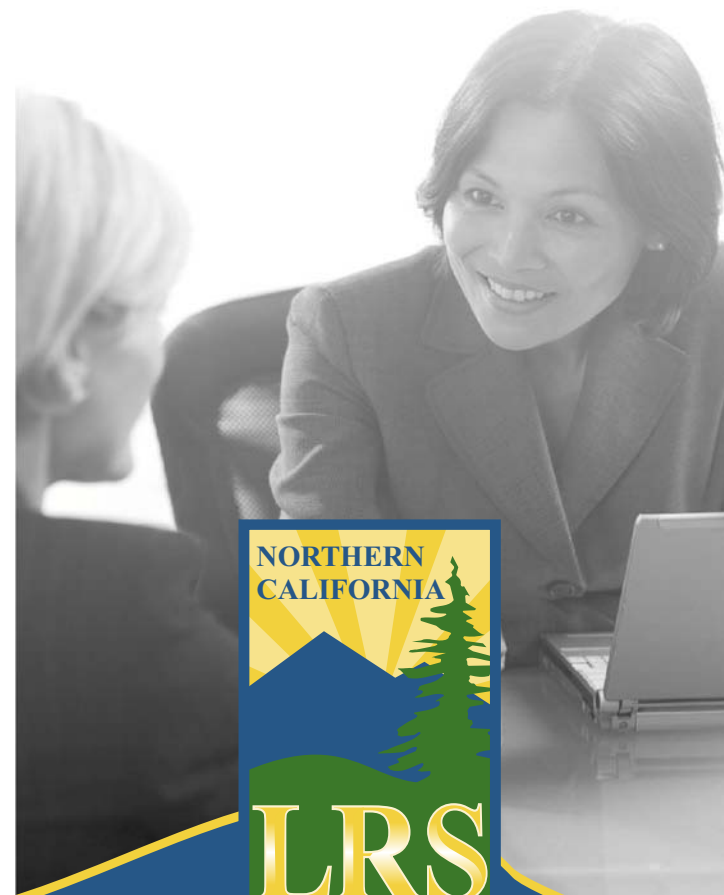

## What is the Lawyer Referral Service?

The Lawyer Referral Service (LRS) refers potential clients to lawyers. This means that if you want to talk to a lawyer and don't know one, a lawyer referral service is a good place to call.

Our Lawyer Referral Service is certified by the State Bar and conforms to standards adopted by the California Supreme Court. Northern California Lawyer Access is the only LRS certified to refer lawyers in the counties of Butte, Colusa, Del Norte, Glenn, Humboldt, Lake, Lassen, Mendocino, Modoc, Nevada, Placer, Plumas, Shasta, Sierra, Siskiyou, Sutter, Tehama, Trinity, and Yuba.

## How Does the Lawyer Referral Service Work?

You may contact the Lawyer Referral Service by telephone, email, or through our website. The LRS staff will determine the type of lawyer you may need and match you with a lawyer who is experienced in the appropriate area of law.

The processing fee for arranging an initial consultation is \$35.00. Fee waivers may be available if you meet specific income and asset guidelines.

The lawyer will provide you with an initial consultation about your matter. After the initial consultation, it is up to you whether or not you want to hire the lawyer.

## What Does the Initial Consultation Consist of?

At the initial consultation (30 minutes), you may discuss your legal matter with the lawyer who will determine if the lawyer can assist you and the estimated fees for legal representation. Please note that the lawyer will not provide free services after the initial consultation. You and the lawyer will discuss the costs of legal services during the initial consultation.

## Why Should I Use LRS?

The LRS is the only non-profit lawyer referral service in the Northern California region certified by the State Bar of California. The LRS lawyers are members of the California State Bar and have been screened to ensure that they have had no disciplinary action that would affect the quality of representation. All LRS lawyers are covered by malpractice insurance.

In limited cases LRS may be able to assist you with our Direct Services program. We have a panel of pro bono lawyers in some areas of law. Also, if you are seeking guardianship of your grandchild in the Nevada County Courts, we may be able to provide a lawyer to represent you at your initial guardianship hearing through a special program offered with support from the County of Nevada Community Initiative Partners program.

Lawyers are also available who may represent you on a Limited Scope basis. Our staff can inform you about this form of legal representation.
